CFOP Ergonomic Safety - Article XXVII Health & Safety, Section: Computers/Ergonomic Safety, Paragraph 1, of the CFOP Collective Bargaining Agreement reads "The Board shall provide safety and health related work station features, and workstation designs in accordance with accepted Ergonomic principals for any CFOP represented employee who is assigned to work at a computer on a regular basis of 2.5 hours per day or more." Handbook Alert: Shake Off Those Blue Jean Blues! - Several principals have included provisions in school handbooks that purport to define professional dress. No principal has the authority to prohibit jeans or gym shoes, or to require men to wear a suit and tie or bow tie.

Our collective bargaining agreement states that teachers are expected to adhere to professional standards with respect to grooming (Section 220(8)(a)). That is as much as it says on the matter. If your principal tries to get the ILT to approve a handbook that includes a dress code, please tell your ILT reps to vote against it. School-based dress codes are unnecessary and inappropriate. Even ILT-approved dress codes are inconsistent with the contract and therefore impermissible. Administrators should not be the fashion police.

CFT/CFOP will be working with the Administration to clarify what topics are appropriate for school handbooks. Stay tuned for news on this front.
